**Minutes** of the January 16 meeting. Noted that the Financial Report was not showing as moved or seconded. Minutes approved, moved by Bonita Carrothers, seconded by Ryan.

**Financial report.** Presented by treasurer Shannon Adams. Money allocated in the budget to cover library services by Carleton Place.

Motion 2019-3. That \$2252.00 allocated in the proposed 2019 budget for Carleton Place be transferred to the "Paper books" budget.

Moved by Joan Sargeant, seconded by Jeannette Bosman.

There was some discussion about investing part of the reserve. The decision was to invest \$25,000 for 1 year with Tangerine.

Motion 2019-4 Moved that the Lanark Highlands Public Library, through its treasurer, invest \$25,000 form the reserve funds, with Tangerine financial, for a period of 1 year, at 2.6%. Moved by Bonita Carrothers, seconded by Jeannette Bosman.

**Policies** Eight policies were presented for review and adoption by Bonita Carrothers. Four of these, foundational policies, are intended to provide direction and support for developing a vision statement, values statement, and mission statement, The fifth foundational policy is an acknowledgement of our position on indigenous lands.
